The undersigned, for the purpose of forming a corporation under the Florida General Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE  
CORPORATE NAME

The name of this corporation is LAMIKE VIDEO, INC.

ARTICLE TWO  
NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE THREE  
CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 500 shares of common stock without par value.

ARTICLE FOUR  
TERM OF EXISTENCE

This corporation shall have perpetual existence upon filing of these articles.
