ARTICLE I - NAME

The name of this corporations is JAMAICAN BREEZE.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date these Articles of Incorporation are filed in the Office of the Secretary of State, State of Florida.
