AMENDMENT





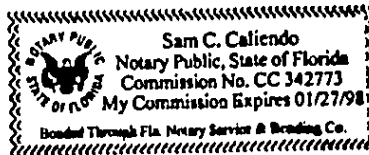
