Dear Sir:

We are a small business and filed our Articles of Incorporation on October 4, 1996. We engaged the help of an accountant to help us with the pertinent paperwork regarding the setting up of a new corporation. We believed that the fees required for 1997 were paid, even though we do not have any records of the payment being made. Due to our lack of information, knowledge and inexperience, we failed to submit the 1997 Profit Corporation Annual Report.

In July 1997 we moved our business to 835 N.E. 125th St., N. Miami, FL 333161. We have never received the 1998 Profit Corporation Annual Report Packet.

On July 1, 1998, we tried to make some changes to certain accounts to show the name of the corporation, and it was at this time that we became aware that the corporation was cancelled. At this time, we called the Department of State to find out what was the problem and was informed that the above mentioned reports had not been submitted. Immediately we requested the necessary reinstatement forms and were informed that they were going to be sent by return mail. On July 13, not having received the requested forms, we called your office once more and spoke to one of your associates and he promised to send the forms immediately, and to return the Application for Reinstatement with a check in the amount of \$315.00, which will reinstate the corporation.

Enclosed please find the Application for Reinstatement and our check in the amount of \$315.00. We hope that this will reinstate our corporation to good standing with the Department of State. We apologize for the inconvenience.
