ARTICLES OF INCORPORATION
OF

The undersigned, being natural persons, competent to contract and for the purpose of forming a corporation for profit under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE I

NAME

The name of the Corporation is:

SUNCHASE TRANSPORTATION, INC.

ARTICLE II

CORPORATION DURATION

This Corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE III

PURPOSE OR PURPOSES

The purpose or purposes for which this Corporation is organized are to engage in any or all lawful business or trade which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on and as permitted under the Florida General Corporation Act.

CAPITALIZATION

The aggregate number of shares which the Corporation is authorized to issue is 1,000 shares. Such shares shall be of a single class designated as "Common Stock" and shall have a par value of TEN DOLLARS (\$10.00) per share.

Three hundred (300) shares of stock shall be issued to each of the incorporators and the balance of Four hundred (400) shares shall remain in the Corporation or as otherwise designated by the Board of Directors.

ARTICLE V

REGISTERED OFFICE, AGENT AND PRINCIPAL OFFICE
