ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I
NAME

The name of this corporation is DOROTHY WOLTERING, INC.

DURATION

The period of its duration is perpetual.

ARTICLE III
PURPOSE

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida; including to conduct, carry on, operate, and engage in any lawful business..

The minimum capital with which this corporation shall begin business is \$5,000.00.

**ARTICLE IX
PRE-EMPTIVE RIGHTS**

Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding. this right shall be deemed waived by any shareholder who does not exercise it and pay for the shares pre-empted within thirty (30) days of receipt of notice from the corporation.

**ARTICLE X
DISSOLUTION, LIQUIDATION**

In the event of the dissolution, whether voluntary or involuntary, liquidation, distribution of assets, or winding up of the corporation, the holders of common stock shall be paid an amount equal to 100% of the par value of such common stock, with the balance of all assets and funds remaining to be distributed to the holders of common stock in the manner provided for in the Bylaws of the Corporation.
