

ARTICLES OF INCORPORATION
OF
TONER DISTRIBUTING OF KENTUCKY, INC.
(A For Profit Corporation)

ARTICLE I - Name

The name of this Corporation is:

TONER DISTRIBUTING OF KENTUCKY, INC.

ARTICLE II - Duration

This Corporation shall have perpetual existence.

ARTICLE III - Purposes and Powers

This Corporation is organized for the purpose of and shall have the authority to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, (1989) as presently enacted and as it may be amended from time to time.

ARTICLE IV - Capital Stock

This Corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock, which shall be designated as "Common Shares".

ARTICLE V - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock or authorized but unissued stock of this corporation of the same kind, class or series as that which he already holds, shall have the

right to purchase his pro-rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - Initial Registered Office and Agent

The street address of the initial registered office of this Corporation is 705-A Live Oak St., Tarpon Springs, FL, 34689, and the name of the initial Registered Agent of this Corporation at that address is John Barbee, Jr.

ARTICLE VII - Initial Board of Directors

This Corporation shall initially have one (1) director. The number of directors may either be increased or diminished from time to time in accordance with the provisions of the bylaws but shall never be less than one (1). 
