ARTICLE I - NAME

ARTICLE III - PURPOSE FOR WHICH CORPORATION IS ORGANIZED

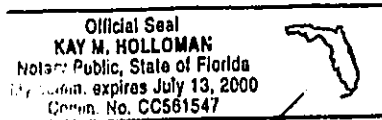
