The owner of the company is located in Brazil, S.A. at this time. The report was sent to him in Brazil for signature. The customary form of business in that country is to have all documents notarized by a para-legal.

This para-legal is sort of a middleman between citizens, businesses and government agencies. This is a licensed individual who has passed a state administered test. It is a bureaucratic job which is held in high esteem in that country. All transactions such as obtaining occupation licenses, auto tags, protesting tax matters, etc. must go through this type of office and office procedure.

They were unaware that this procedure was not necessary in the United States. They did not realize that there was a May 1st deadline for the filing of this return.

We have been hired to do their accounting work and just came upon this matter.
