ARTICLE I

The name of this corporation is **K.R.K. RADIO ENTERPRISES, INC.**

ARTICLE II

This corporation is organized for the sole and specific purpose of transacting any and all lawful business for which corporations may be incorporated in the State of Florida.

The aggregate number of shares of stock which the corporation is authorized to issue and have outstanding at any time is Sixty (60) Shares of Common Stock, which shall have a par value of One (\$1.00) Dollar.

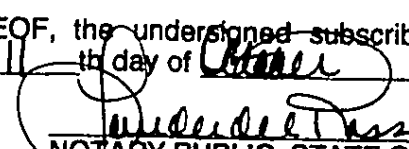

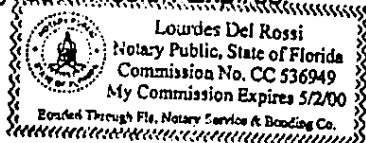

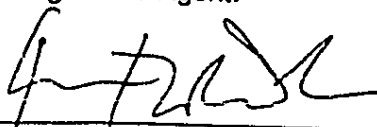
