## ARTICLES OF INCORPORATION OF BAKHT, INC.

DIVISION OF STATE OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is BAKHT, INC.
