CERTIFICATE OF INCORPORATION OF

We, the undersigned, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the Several Acts of Legislature of the State of Florida, do hereby audicribe to this certificate of incorporation.
