ARTICLES OF INCORPORATION
OF
DEVELOPMENT ENTERPRISES, INC.

ARTICLE I
NAME

The name of this corporation is DEVELOPMENT ENTERPRISES, INC.

ARTICLE II
PURPOSE

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III
CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of common stock.

The common stock of the corporation shall have the following characteristics:

- (a) Par value shall be \$0.001 per share.
