

ARTICLE ONE

The name of the corporation is **KING NEPTUNE'S POOL SERVICE, INC.** The principal address of the corporation is: 2800 S. University Drive, Unit 2C, Davie, Florida 33328.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR


The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) of no par value.


#### ARTICLE EIGHT
