The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

PROVIDER MANAGEMENT CONCEPTS, INC. and its address is: 2807 W. Busch Boulevard, Suite 107, Tampa, Florida 33618-4518.

<u>Article 2. Duration</u>. The duration of the Corporation is perpetual.
