The undersigned subscriber to these Articles of Incorporation, a natural person and the State of Florida STATE competent to contract, hereby forms a corporation under the laws of the State of Florida SEE, FLORIDA

# ARTICLE I

The name of this corporation is VOICE LINK COMMUNICATIONS, INC.

#### **ARTICLE II**

The general nature of this business to be transacted by this corporation is telecommunications and related sales and services.

- To engage in any activity or business permitted under the laws of the United States and of this State.
- 2.
