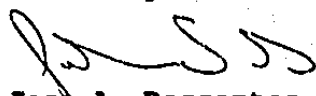

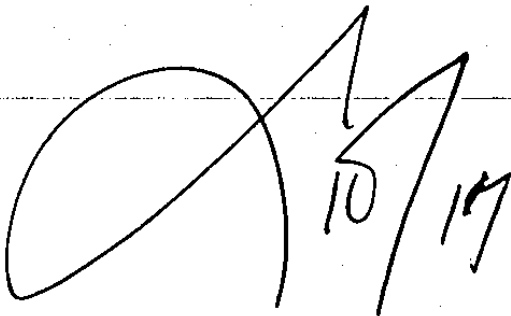

The understanding subscriber to these Articles of Incorporation, a natural person, authorized to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Gulf Coast Brick Pavers, Inc. The principal place of business of this corporation shall be 600 Starkey Road, #902, Largo, FL 33771.

ARTICLE II - NATURE OF BUSINESS

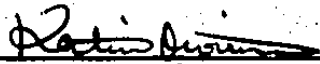
