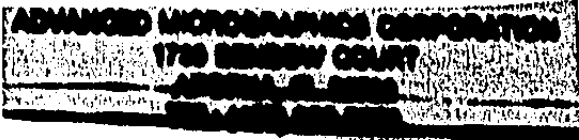

ARTICLE I - NAME

The name of this corporation is ADVANCED DATA CORP., INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - INITIAL MAILING ADDRESS

The initial mailing address of the corporation shall be 1733 Benbow Court, Apopka, Florida 32704. This address may be changed and a principal office established and/or relocated without amending these Articles of Incorporation.

ARTICLE IV - PURPOSE

This corporation is organized for the purposes of conducting any and all lawful business transactions in Florida, the United States and throughout the world.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of voting Common Stock having a Par Value of \$1 per share.

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE X - PREEMPTIVE RIGHTS

ARTICLE XI - AMENDMENTS


