Articles of Incorporation of Flodex, Inc. file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I: The name of the corporation shall be: Flodex, Inc.

ARTICLE II: The corporation may engage in any and all lawful business permitted under the laws of the State of Florida.
