ARTICLES OF INCORPORATION
OF

ARTICLE I: Name: The name of the corporation is BIG CAT CONTRACTORS, INC.

ARTICLE II: Duration: The corporation shall have perpetual existence commencing on the date of filing of these Articles.

ARTICLE III: Purpose: This corporation is organized for the purpose of providing home repair services, including but not limited to painting, pressure washing and other repairs, and to transact any and all lawful business and to exercise all powers granted to corporations by the State of Florida.
