

The undersigned, for the purposes of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation.

1. The name of the corporation is Instant Diagnostics Inc.
2. The street address of the initial principal office of the corporation is 255 Capri Circle #8, Treasure Island, Florida 33706.
3. The duration of the corporation is perpetual.
4. The general purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under Florida Business Corporation act.
5. The aggregate number of shares which the corporation is authorized to issue is 3,000. Such shares shall be of a single class, and shall have a par value of one dollar per share.
6. The corporation elects to have preemptive rights; each shareholder of the corporation shall have the right to purchase or subscribe to any stock or obligation of any class that the corporation may issue for any consideration.


