ARTICLE I

CORPORATE NAME

The name of the Corporation shall be:

NATURE OF CORPORATE BUSINESS

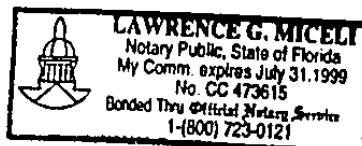
