ARTICLES OF INCORPORATION
OF

GREATER TAMPA BAY GYMNASTICS ASSOCIATION, INC.

The undersigned, acting as the incorporator of Greater Tampa Bay Gymnastics Association, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:
