The undersigned incorporator, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be:

TERM OF EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III

GENERAL NATURE OF BUSINESS

This corporation may engage in or transact any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV

POWERS

This corporation shall have all such powers as may be permissible to corporations under the laws of the State of Florida, and all powers necessary or desirable to accomplish the purposes and businesses of the corporation as hereinabove set forth in Article III.

ARTICLE V

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one class of seventy five hundred (7500) shares of common stock with a par value of One Dollar (\$1.00) per share.

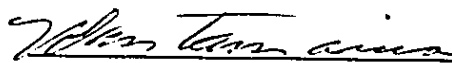
ARTICLE X

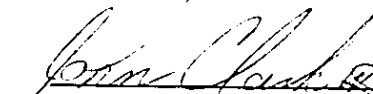

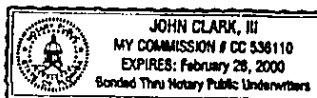
