RICKY HILL, a natural person, competent to contract? we hereby make, acknowledge and file in the Office of the Secretary of the State of Florida, for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida and pursuant to the Florida General Corporate Act, these Articles of Incorporation.

# ARTICLE I

## NAME AND ADDRESS

The name of the Corporation shall be KOYAMA ENTERPRISES, INC. The principal office and mailing address of the Corporation is 411 S.E. 4th Terrace, Dania, FL 330C4.

# ARTICLE II

# GENERAL PURPOSE

The general purposes for which this Corporation is organized are:

A) The wholesale/retail sale of saltwater products and supplies; and employ personnel for the purpose of or in connection with said business in every kind or character, and to do any and all things necessary and proper to effect such purpose.
