The undersigned, acting as a subscriber of a corporation under Florida Corporation Law adopts the following Articles of Incorporation for such corporation.

ARTICLE I
NAME

The name of this corporation is JAIME MARCHAND, M.D., P.A.

ARTICLE II
PURPOSE

The purpose for which corporation is organized is to engage in the active and lawful practice of medicine in the State of Florida and in the United States of America.

ARTICLE III
DURATION

The period of duration for the corporation is perpetual, unless sooner dissolved according to law.

ARTICLE IV
CAPITAL STOCK

The aggregate number of shares which the corporation has the authority to issue is 1000 shares, all of which shall be common shares with par value of \$1.00 per share.

ARTICLE V
CAPITAL

The amount of capital with which the corporation shall commence business shall not be less than ONE THOUSAND AND NO/100 DOLLARS (\$1,000.00)

ARTICLE VI
PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same

kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


