ARTICLES OF INCORPORATION OF JAIME MARCHAND M.D., P.A.

The undersigned, acting as a subscriber of a corporation under Florida Corporation Law adopts the following Articles of Incorporation for such corporation.

ARTICLE I
NAME

The name of this corporation is JAIME MARCHAND, M.D., P.A.

ARTICLE H PURPOSE

The purpose for which corporation is organized is to engage in the active and lawful practice of medicine in the State of Florida and in the United States of America.

ARTICLE III DURATION

The period of duration for the corporation is perpetual, unless sooner dissolved according to law.

ARTICLE IV CAPITAL STOCK

The aggregate number of shares which the corporation has the authority to issue is 1000 shares, all of which shall be common shares with par value of \$1.00 per share.

ARTICLE V CAPITAL
