1. The name of the corporation is KEYS ASSOCIATES INTERNATIONAL INC. ("Corporation").

2. The Amendment: Article I of the Articles of Incorporation of the Corporation is amended to read in its entirety as follows:

ARTICLE I  
NAME AND PRINCIPAL OFFICE


