ARTICLES OF INCORPORATION

I, the undersigned, hereby make, subscribe, acknowledge and file these Afficles for the purpose of forming a Corporation under the laws of the State of Florida.

10 -15 -90 ARTICLE I

The name of this Corporation shall be LAW MART ATTORNEY REFERRAL SERVICE, INC.

<u>ARTICLE II</u>

PURPOSE

This Corporation is organized for the purpose of attorney referral services and other lawful business.

ARTICLE III

CAPITAL STOCK

Any Shareholder or Director may waive notice of the time, place and purpose of any meeting, either before, at, or after such meeting.
- 2. Directors, individually or jointly, may be a party or parties to, or may be interested in any such contract or transaction of the Corporation, or in which the Corporation is interested, and no contract, act or transaction of the Corporation with any person or persons, firm or Corporation, in the absence of fraud, shall be affected or invalidated by the fact that any Officer, Officers or Directors of the Corporation is a party or parties to or interested in such contract, act or transaction, or in any way connected with such person or persons, firm or Corporation, and each and every person who may become an Officer or Director of this Corporation is hereby relieved from any liability that might otherwise exist from, thus contracting with the Corporation for the benefit of himself or any firm, association or Corporation which he may be in any way interested.
