ARTICLES OF INCORPORATION

OF

BEBE PHERAI INVESTMENTS, INC.

ARTICLE I. NAME

The name of this corporation is BEBE PHERAI INVESTMENTS, INC.

ARTICLE II. PURPOSE

This corporation is organized for the following purpose(s):
