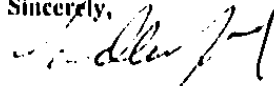

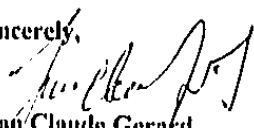

OF

The undersigned incorporator to these articles of incorporation, a natural person, competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be THE FLORIDA REPORT, Inc. The initial street address in the State of FLORIDA or initial registered office of the corporation is:

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The nature of the business and the objects and purposes proposed to be transacted, promoted or carried on are to engage in any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having par value of one (\$1.00) Dollar per share.

ARTICLE VIII

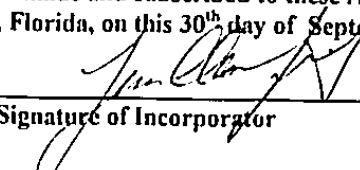
