ARTICAL I

NAME

The name of this corporation is Karon K. Sheppard, P. A..

ARTICLE II

PURPOSE

This corporation is organized for the purpose of engaging in the business of real estate sales and services, and any other activity or business permitted under the laws of the United States and the State of Florida.
