

ARTICLES OF INCORPORATION OF WALLER AVIATION, INC.



The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE: NAME

The name of the Corporation is WAHLER AVIATION, INC. The principal address is 3132 Harvardston Loop, Holiday, FL 34691.

ARTICLE TWO: TERM OF EXISTENCE

The duration of the Corporation is perpetual. Corporate existence is to commence on the date of filing of the Articles of Incorporation by the Secretary of State.

<u>ARTICLE THREE: NATURE OF BUSINESS</u>

The aggregate number of shares which the Corporation is authorized to issue is Five Hundred (500), One Hundred (100) of which will be issued at this time as follows: Fifty (50) Shares to EDWARD W WAHLER and Fifty (50) Shares to KATHY WAHLER. Said shares shall be of a single class and have a par value of Five Dollars (\$5.00) per share.

ARTICLE FIVE: INITIAL CAPITAL

The amount of capital with which the Corporation will begin business is Five Hundred Dollars (\$500.00). Capital contributions shall be in cash or other equivalent property, but shall not include services.

ARTICLE SIX: ADDRESS


