ARTICLES OF INCORPORATION

ARTICLE I - Name and Address

The Name of this corporation is AMS IV, Inc. (hereafter referred to as the Corporation.) The Corporation's principal address is 941 S.W. 8th Street, Pompano Beach, FL 33069.

ARTICLE II - Duration

This Corporation shall have perpetual existence commencing on October 17, 1996, the date these Articles of Incorporation are filed with the Florida Department of State.

ARTICLE III - Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - Powers
