ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act., adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of the Corporation is COLUMBIAN EXPRESS CORP.

The period of duration is perpetual.

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

The Corporation shall have the authority to issue 7500 Shares, all in one class, \$1.00 par value.

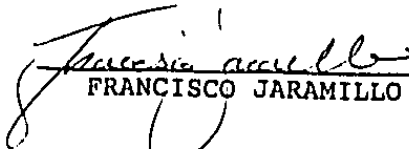
ARTICLE VII

The preemptive right of any holder is determined by the ratio of the authorized (authorized and issued) shares of common stock held by the holder to all shares of common stock currently authorized (and issued).

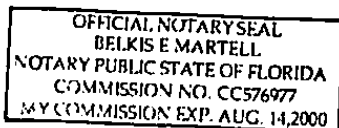

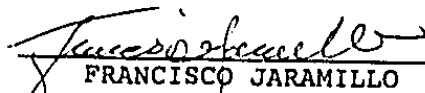
