ARTICLES OF INCORPORATION OF RGB WEST, INC.

The undersigned, acting as incorporator of a corporation under the Philap- \mathcal{C}_{i} General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE

NAME AND PRINCIPAL OFFICE

The name of this corporation is RGB WEST, INC., and its principal office is located at 31 West Garden Street, Suite 101, Pensacola, Florida 32582, and its mailing address is P.O. Box 358, Pensacola, Florida 32582.

ARTICLE II

DURATION

This corporation shall exist perpetually, commencing upon the date of subscription and acknowledgment of these Articles of Incorporation.

ARTICLE III

PURPOSE
