ARTICLE I - NAME

The name of the corporation shall be W. H. PRESCOTT, P.A. The mailing address for the corporation is P. O. Box 40147, Sarasota, FL 34242.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE
