ARTICLES OF INCORPORATION  
FOR  
PIPELINE MARKETING AND CONSULTATION SERVICES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation is PIPELINE MARKETING AND CONSULTATION SERVICES, INC. The principal address is:

Duration

The duration of the corporation is perpetual.


