ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, both natural persons competent to contract, hereby form a Corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be PURITAN PRODUCTS INCORPORATED The principle place of business of this Corporation shall be 9012 Baywood Pk. Dr. Seminole, Fl. 33777. The mailing address shall be P.O. Box 3444 Seminole, Fl. 33775-3444

ARTICLE II. NATURE OF BUSINESS

The Corporation is formed to engage in Domestic, International, Industrial, Commercial, Manufacturing, Sales, Service related activities, The Corporation may not be limited to the activities listed above and may expand into other areas of business enterprise as the market demands and opportunity arises.

These activities will be accomplished in accordance with the laws of the United States of America, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is 7,500 shares of common stock having a par value of \$1.00 per share

ARTICLE VIII. DIRECTORS

This Corporation shall have no directors initially. The affairs of the Corporation will be managed by the Shareholders until such time as directors are designated as provided by the Bylaws.




