ARTICLE I - Name

The name of this corporation is PAIR RECOVERY SYSTEMS, INC. The mailing address and the principal place of business shall be 5116 Villa Nova Road, Kissimmee, Florida 34746.

ARTICLE II - Duration

This corporation shall exist in perpetuity, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - Capital Stock

This corporation is authorized to issue 500 shares of \$1.00 par value common stock.

ARTICLE V - Pre-emptive Rights

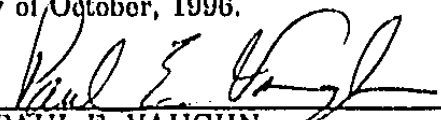
ARTICLE IX - Bylaws

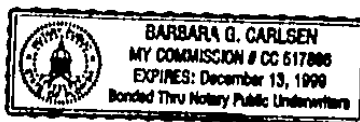
