### ARTICLES OF INCORPORATION

OF

# PUTHENPURACKAL A. THOMAS, D.D.S., M.D.S., P.A.

I, the undersigned incorporator, hereby make, subscribe, acknowledge and file with the Secretary of State of Florida, these Articles of Incorporation for the purpose of forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act.

### ARTICLE I

### Name

The name of the corporation shall be PUTHENPURACKAL A. THOMAS, D.D.S., M.D.S., P.A.

#### ARTICLE II

#### Purpose

The purpose of the corporation is to render the practice of dentistry to the public, which shall consist of the actual diagnosing, treating, prescribing, or operating in any degree, or professing or attempting to diagnosis, treat, prescribe or operate for, any disease, pain, deformity, deficiency, injury or physical condition of the human tooth, teeth alveolar process, gums or jaws, or their dependent tissues.

This professional corporation shall exist and function in compliance with the Florida Professional Service Corporation and Limited Liability Company Act and in order to properly prosecute the objects and purposes above set forth, the corporation shall have full power and authority to purchase, lense and otherwise acquire, hold, mortgage, convey and otherwise dispose of all kinds of property, both real and personal, necessary for the rendering of the service of the practice of dentistry.


