ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be Agricultural Commodities, Inc.

ARTICLE II. PURPOSE AND AUTHORITY

The corporation shall engage in all aspects of the agricultural commodities business, including brokerage, sales and consulting, both directly and through divisions, for the purpose of producing a profit. The corporation shall also be authorized to engage in any other activity permitted by the laws of Florida and the United States.

ARTICLE III. CAPITAL STOCK

The maximum number shares of stock that this corporation is authorized to issue is 5,000 shares of common stock having a par value of \$1.00 each.

ARTICLE IV. ADDRESS

The street address of the initial registered office of the corporation, which is the corporation's principal office and mailing address, shall be, 2941 Eagle Estates Circle, South Clearwater, FL 34621 and the name of the initial registered agent of the corporation at that address is John J. The term of existence of the corporation is to be perpetual.

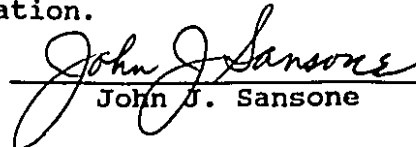
