ARTICLES OF INCORPORATION OF

POLICE MANAGEMENT AND TRAINING CONSULTANTS, INC.

SECRETARY OF STATE TALLAHASSEE. FLORIDA

Article 1

Name. The name of this Corporation is POLICE MANAGEMENT AND TRAINING CONSULTANTS, INC.

Article II

<u>Principal Office</u>: The principal place of business and mailing address of this corporation shall be: 519 N.W. 102nd Terrace, Gainesville, FL 32607.

Article III

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.

Article IV
