ARTICLE I. NAME

The name of the corporation is Ocala Gun Range, Inc.

ARTICLE II. DURATION

This corporation shall exist perpetually.

This corporation shall commence corporate existence on the filing date of the Articles.

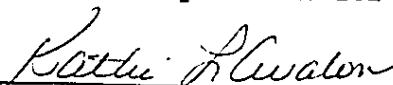

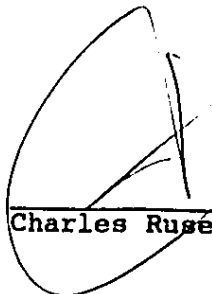

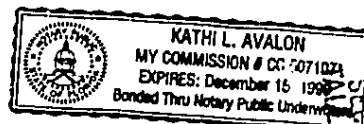
