ARTICLES OF INCORPORATION
OF
WEST COAST CONVENTION ELECTRIC, INC.

The undersigned incorporator, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is WEST COAST CONVENTION ELECTRIC, INC.

ARTICLE II - DURATION

The duration of the corporation is perpetual. Corporate existence is to commence on the filing of the Articles of Incorporation.
