#### ARTICAL I

NAME

The name of this corporation is David Pransky, P.A..

#### ARTICAL II

#### PURPOSE

This corporation is organized for the purpose of engaging in the business of real estate sales and services, and any other activity or business permitted under the laws of the United States and the State of Florida.

#### ARTICAL III

#### CAPITAL STOCK

The amount of capital stock authorized by these Articals of Incorporation, being the maximum shares of stock which the corporation is authorized to issue and to have outstanding at any time shall be One Thousand (1000) shares of common stock.
