Please find enclosed two articles of amondments for a name change to two separate corporations. They should be processed in the following order:

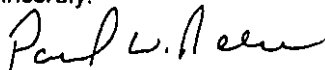
- 1) Name change of Best Funding Corporation to Best International Enterprises, Inc.
