ARTICLES OF INCORPORATION OF JUAN BELLON FARMS, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is JUAN BELLON FARMS, INC.

ARTICLE II - NATURE OF BUSINESS
