ARTICLES OF INCORPORATION OF GIBRALTAR MORTGAGE COMPANY

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, a is the following Articles of Incorporation:

Article I

Name and Principal Office

Section 1.1. Name. The name of the corporation is GIBRALTAR MORTGAGE COMPANY
