- ARTICLES OF INCORPORATION -

In compliance with the requirements of F.S. Chapter 607, the undersigned, Catherine A. Kaczmariski, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

ARTICLE I - Name

The name of the Corporation is BLUE MOON BUSINESS VENTURES, INC.

ARTICLE II - Duration

The existence of the Corporation shall begin upon the filing and acceptance of these articles by the Secretary of State of the sovereign State of Florida.

ARTICLE III - Addresses

ARTICLE IV - Capital Stock
